Roseville Community Development Corporation Seeks Board Member

The Roseville Community Development Corporation (RCDC) is seeking individuals interested in serving as a board member. The recruitment is for two Board Members for a term that will expire February 2019 and two Board Members for a term of 3 years that will expire January 2020. Applications will be accepted until November 14, 2016. Following an interview with RCDC staff, the RCDC Board will recommend candidates to the Roseville City Council for appointment in January 2017.

Fill out only the schedules applicable to you and print them. After completing your statement, be sure to **review, sign and date** the document and indicate the total number of pages included. File only the cover page and any schedule(s) you have completed.
